Section 2: Vendor Showcase Information

- Any company interested in participating in the Vendor Showcase, **must be** exhibiting at the meeting.
- Presentations take place in the Exhibit Hall in the Innovation Room and run parallel (opposed) to AAPM sessions and during breaks (unopposed).
- Vendors are able to determine their presentation topic(s); however, all information must be submitted to AAPM for approval. Presentations can include sales information. Speakers will be expected to follow the general guidelines for all AAPM Speakers.
- Exhibitors are prohibited from attending another Vendor's Showcase.
- The list of attendees who participate in a Vendor Showcase will not be provided. However, Vendors are encouraged to use a Lead Retrieval system to capture attendee information. Information to rent a Lead Retrieval System will be available in the Exhibitor Service Kit.

Vendors may request a maximum request of TWO Vendor Showcases:

\$2,500 — 30-minute Time Slot (running parallel/opposed with AAPM meeting sessions)

\$5,000 — 30-minute Time Slot (running unopposed with AAPM meeting sessions)

\$7,500 — 60-minute Time Slot (during lunch break)

Included with this fee:

- Your presentation will be listed in the Meeting Program in the "Exhibition" track.
- AAPM will promote the Vendor Showcase schedule in Social Media blasts.
- Standard AV will be provided in the room.
- Rooms will be set for approximately 150 attendees.
- The Vendor Showcases will not be captured. Vendors will have the opportunity to provide AAPM with a narrated presentation to be posted during the on-demand period.
