



## Shipping & Customs FAQ

AAPM partners with **LibertyCFS** as the **Official Freight & Customs Provider**.

### Why should I use the official partner, LibertyCFS?

**LibertyCFS is the designated provider for cross-border logistics.** Benefits include:

- **Ease of Entry:** **LibertyCFS** will assist in preparing **ALL** your customs documents. **Plan in advance** and avoid any last-minute shipments that may incur any delays.
- **Expertise:** They specialize in international freight forwarding, customs brokerage, and door-to-door service.
- **On-Site Support:** They are fully integrated with show move-in and move-out schedules.

**Note: Non-Canadian exhibitors, contact Liberty as early as possible** to ensure your shipments is set-up and customs paperwork completed correctly, and, note that certain commodities such as medical devices, pharmaceutical products, cosmetics, foodstuffs, beverages, certain electronic and telecommunication and military items, animal & plant products (CITES) will be subject to import license or other certification requirements. **Kindy contact LibertyCFS at least 2 months prior to the show if sending any of the above items.**

### What are my shipping destination options?

You have **two primary options** for getting materials to Vancouver:

- **Option 1: Advance Warehouse (Recommended)**  
**Window:** June 12, 2026 – July 10, 2026.  
**Address:** AAPM 2026, [Exhibiting Company Name], Booth #, c/o Aerostream, 18391 McCartney Way, Richmond, BC V6W 0A1.
- **Option 2: Direct-to-Show Site**  
**Window:** **No shipments can arrive before July 16, 2026, at 8:00 AM.** Shipments arriving prior to this date & time will be refused.  
**Address:** AAPM 2026, [Exhibiting Company Name], Booth #, Vancouver Convention Centre - West, c/o Levy Exposition Services, via Waterfront Road Truck Route, 1055 Canada Place, Vancouver, BC V6C 0C3.

### What are the mandatory shipping requirements?

- **Packaging:** All freight must be properly crated, boxed, or stretch-wrapped on pallets.
- **Labeling:** Every piece must be labeled with the company name, booth number, and event name.
- **Weight Tickets:** All shipments must include a certified weight ticket.  
**Note:** Missing tickets incur a \$0.25/lb on-site weighing surcharge.

### When is the final deadline for move-out?

- **Carrier Check-in:** Your carrier must check in no later **than 2:00 PM on July 22, 2026.**
- **Forced Freight:** If your carrier is late, the shipment will be rerouted via the official carrier at the exhibitor's expense.
